### FREQUENTLY ASKED QUESTIONS

#### Q: What is your address?

A: Our physical/mailing address is: Warren County Register of Deeds 109 South Main Street Warrenton, NC 27589

> Our PO Box address is: Warren County Register of Deeds PO Box 506 Warrenton, NC 27589

#### Q: What are your hours of operation?

A: The office is open from 8:30am to 5:00pm, Monday thru Friday.

## Q: Can anyone access the information contained in the Register of Deeds office?

A: Yes. All information in our office is public record.

## Q: How can I obtain general information about the services offered by the Register of Deeds Office?

A: In addition to our website, you may call (252) 257-3265 for assistance.

#### Q: How do I transfer names on a deed?

A: You will need to draw up a new deed. You should see an attorney for this service. You will record the document in the Register of Deeds Office at a cost of \$26.00 for the first 15 pages and \$3.00 for any additional pages. You may also have to pay excise tax. The excise tax amount is \$2.00 per \$1000 of the purchase price.

## Q: How do I obtain initial appointment or reappointment forms for my Notary Public?

A: All notary forms are available on this website under Notary Public. In addition, you may pick up either form from our office or the Secretary of State office (919) 807-2131. You will mail the application form to the Secretary of State. The Secretary of State will then send you a green notice in the mail advising you to take oath at our office. You may not take oath until the effective date listed on the notice.

## Q: Do I need an appointment to take my notary oath? What should I bring with me?

A: No appointment is necessary. Come in any time between the hours of 8:30am and 5:00pm. Bring your green notice from the Secretary of States office. The fee is \$10.00, payable by cash or check.

#### Q: Can I obtain a copy of a birth certificate from your office?

A: Our office keeps records only for births occurring in Warren County. Requests are honored by mail or in person. For more information call (252) 257-3265 or download the form available on this website under Vital Records. NC Vital Records houses birth records for birth in the state of NC. For more information, call NC Vital Records at (919) 773-3000.

## Q: Can the Register of Deeds tell me who owns property at a specific address?

A: If you do not have the owners name, please contact the tax office at (252) 257-4158. We can only look up by name.

#### Q: How do I obtain a copy of my deed?

A: The Register of Deeds Office provides deed copies at \$.05 per page in the office. You may also obtain a copy by visiting the Online Search option on our website for deeds that have been scanned. You may also call our office (252) 257-3265 to have a copy mailed or emailed to you.

#### Q: How do I obtain a copy of the map to my property?

A: The Register of Deeds provides map copies at \$ .05 per page and \$.50 per page for the larger maps if it was recorded. The link to the Warren County Tax Mapping website is: <u>www.warrencountync.com</u>.

#### Q: Where can I get a tax map, PIN or aerial map?

# Q: How do I find out about outstanding liens (mechanics liens) and judgments?

A: Contact the Clerk of Circuit Office at (252) 257-6300.

#### Q: What steps do I take to get married?

- A: You must call the Register of Deeds office to make an appointment for a marriage license. The license is valid for 60 days. The cost of the marriage license is \$60.00. A religious officiate or a magistrate may perform the ceremony. For more information, please refer to our website under MARRIAGE or call our office at (252) 257-3265.
- Q: Once I have obtained a marriage license, whom do I speak with about a civil ceremony or marriage by the magistrate?
- A: Marriages are performed in the Magistrates office by a Magistrate. Please call (252) 257-6325 for more information regarding the ceremony, office hours, etc.

#### Q: How do I change my name after I get married?

A: You will need a certified copy of your marriage license for a name change on your driver¢ license and your social security

#### Q: How do I obtain a copy of my marriage license?

A: If your marriage took place in Warren County, you may request a copy by mail or in person. Copies are available at least 10 days after the wedding ceremony. To process the request, we need the name of the bride and groom plus the date of the marriage. A certified copy of a marriage license is \$10.00. A self-addressed stamped envelope is appreciated.

#### Q: How do I obtain a copy of my divorce?

A: If the divorce was processed in Warren County, you may obtain a copy from the Clerk of Court Office on the first floor of the courthouse or call (252) 257-6300 for more information,

#### Q: How do I file for separation papers?

A: It is advisable to see an attorney. The recording fee is \$26.00 for the first 15 pages and \$3.00 for each additional page.

#### Q: Do you take credit cards?

A: No, cash, check or money orders only.
